The annual International Conference “Theoretical and Applied Ethics: Traditions and Perspectives - 2019” is continuing the tradition of holding international ethical conferences established in 2007 at the St. Petersburg State University (Institute of Philosophy). The conference is dedicated to investigate the most important ethical issues of the contemporary society and moral categories as well as concepts of practical philosophy. The conference is attended by experts from from Russia (Saint-Petersburg, Moscow, Novosibirsk, Yekaterinburg) Lithuania, Finland, Spain, USA, Argentina, Brazil, Germany, Italy, France, Spain, Belarus, Poland, Slovakia, Japan, Kuwait. The permanent team was built in the previous years, that allow implementing the scientific and publishing partnership. Young scientists are also welcome to participate, as we assume the importance of including them in scientific community. The analysis of the progress and the social changes because of it, are the main theme of our conference in 2019. The discourse of informational, postindustrial or digital society is not new. One hundred years is passed since D. Bell discussed the issues of implementation the progress and its impact on the society, to specify the changes in moral. The certain tradition of analysis and prognosis is formed these years. However, each new trend of the progress demands fresh reception.

This year, the conference aims to analyze the ethical aspect of the extension of the postindustrial, digital society as a society of scientific meritocracy (the knowledge society, the expert society, post-truth and pseudoscience etc.). The development of data and digital technologies causes significant social conversions. These conversions produce transformation of traditional values and stimulate the reversal of individual regulation of intercommunication in social environment.

The results of the conference will be the presented in the following formats:

- 1) Conference proceedings book with the full texts of the conference presentations (ISSN provided);
- 2) Series of papers in peer-reviewed journals based on the results of presentations made at the conference.
